

## **ULI Atlanta Breakfast Tour: Georgian Terrace Hotel**

The ULI Breakfast Tour Series is another new initiative for the Atlanta District. The objective of the Breakfast Tour series is to expose small groups to dynamic real estate projects (under construction or completed) and provide an opportunity to meet the developers and architects and hear about their successes and challenges. Originally built in 1911, the recently renovated nineteen-story atrium and tower Georgian Terrace Hotel is one of the latest editions to the Fremont Realty Capital family.
