### Program Overview:

Despite increased rhetoric about the importance of infrastructure, states and metropolitan areas are struggling to find funds to make basic repairs on aging systems and to build the new transit road networks and other critical infrastructure needed to position themselves for future growth.

America's infrastructure investments - levels of which have long trailed behind those of Asia and Europe - will be further stifled this year by pressures to cut federal spending and reduce the deficit, compelling cities to be evermore creative and resourceful in securing partnerships to start or continue infrastructure projects, according to [Infrastructure 2011: A Strategic Priority](#). This report, released by the Urban Land Institute and Ernst & Young, emphasizes the challenge faced by many urban areas trying to provide adequate transportation and other infrastructure services for their residents, workers and businesses. *A copy of this report is included with your registration.*

- assess the state of infrastructure in the U.S. & around the world;
- examine what the next few years are likely to hold;
- provide recommendations for moving forward on infrastructure investments and strategies that are needed for regions and countries to continue to prosper and grow.
