##### Welcome Cocktail Reception and Presentation at Heaven over Hell's Kitchen

Presentation by David Rockwell, founder of Rockwell Group, an award winning, cross-disciplinary architecture and design practice. Situated within New York's historic Hell's Kitchen neighborhood, Ink48 Hotel's building originates from the 1930s where it was once an old printing factory. With the original building designed by architect Carlos Zapata, along with the three story rooftop addition, it was architect Rockwell who gave the structure a major transformation while still maintaining the original integrity of Zapata's design. Rockwell is a 2010 Emmy Award Winner for his production of the *82nd Annual Academy Awards* and a James Beard Foundation nominee for Best Restaurant Design, *Nobu Fifty Seven*.
