William R. Williams, Director - Architecture and Engineering, City Creek Reserve, Inc. Bill Williams is responsible for overall architectural and engineering design for the City Creek redevelopment project in the heart of downtown Salt Lake City. Adjacent to both the Salt Palace Convention Center and Temple Square, City Creek is a walkable, sustainably-designed urban community of residences, offices and retail stores on nearly 20 acres across three blocks. Upon project completion in early 2012, Salt Lake will be one of few cities in the nation with a vibrant, mixed-use development at its core.

City Creek is one of 60 LEED for Neighborhood Development (LEED ND) pilot projects in the country selected to participate in a focus group to help the U.S. Green Building Council finalize its new LEED ND certification process. Additionally, City Creek's four new residential towers are expected to qualify for some level of LEED NC (New Construction) certification.
